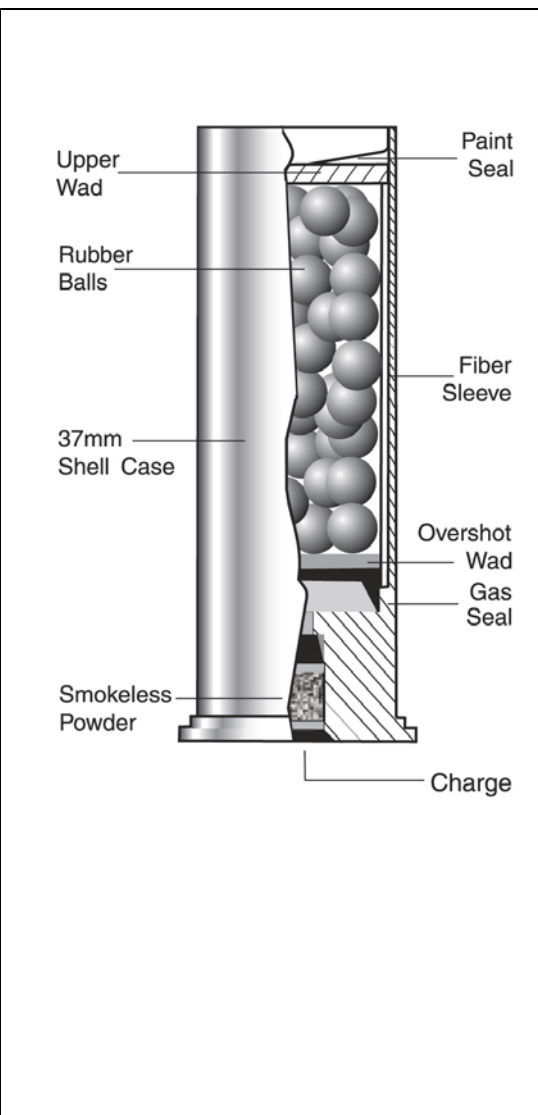

<p>The Stinger® 37/40mm, 32-Caliber Round incorporates a 4.8-inch casing that contains approximately one hundred thirty (130) rubber balls. This Stinger® 37/40mm 32-Caliber Round was designed for departments that utilize both 37mm gas guns and 40mm launchers. This allows sharing of ordnance between the two weapon systems. It also differs from its 37mm counterpart in that it utilizes smokeless powder as the propellant and therefore has velocities that are considerably more consistent and have tighter patterns.</p> <p>The Stinger® 37/40mm, 32-Caliber Round is most widely used as a crowd management tool by Law Enforcement and Corrections. The round is generally deployed in low trajectories or skip fired in the general direction (non-target specific) of the intended targets. It is suitable for administering a means of pain compliance over close to medium distances and for routing crowds or groups that are mildly resistive. The Stinger® 37/40mm, 32-Caliber Round is not well suited as a dynamic, high-energy single subject round for the purposes of incapacitation.</p> <p>The Stinger® 37/40mm, 32-Caliber Round is intended to be skip or direct fired at the discretion of the operator, but it is necessary to keep the trajectory low so the projectile spread will not engage the subject above the breast line. When used in this manner, the operator should be adequately trained in the use of Less Lethal Impact Munitions and have a thorough understanding of the round and considerations of selecting shot placement such as level of threat, target distance, size, and clothing.</p> <p>As a pain compliance round for crowd control, it is most suitable at close to moderate ranges of fire, approximately 15 to 25 feet. This round provides a solution for the non-aggressive, but non-compliant crowd prior to the use of more dynamic munitions. At these ranges, this round will sufficiently supply an impressive sting with little threat of injury.</p>
